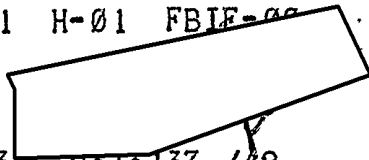

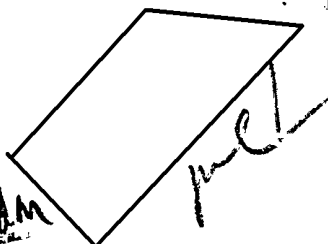

2. BEGIN TEXT: [REDACTED] SWORN STATES:

I LIVE AT PORT KAITUMA AND EMPLOYED AS A [REDACTED]

ON 18TH NOVEMBER, 1978, I WAS AT THE PORT KAITUMA
OUT POST. THERE I SAW THE ACCUSED (IDENTIFIED).
THE ACCUSED WAS TAKEN IN TO THE OUT POST BY ONE

[REDACTED] (IDENTIFIED) AND ONE [REDACTED]

[REDACTED] TOLD US THAT THE ACCUSED

WAS INVOLVED IN THE PORT KAITUMA SHOOTING. HE DID
NOT SAY ANYTHING MORE. I ASKED THE ACCUSED IF
IF WAS TRUE. THEN THE ACCUSED SAID "YES, I
WAS ONE OF THE PERSONS INVOLVED IN THE SHOOTING".
