THE COURT ON THE MORNING OF FRIDAY, OCTOBER 10, RATHER  
THAN ON OCTOBER 9 AS ORIGINALLY PLANNED. HE SAID THIS  
WOULD BE DONE WITH THE UNDERSTANDING BY LAYTON AND HIS  
ATTORNEYS THAT LAYTON WOULD AGREE TO DEPART GUYANA FOR  
NEW YORK ON THE AFTERNOON'S PAN AM FLIGHT OR BE IMMEDIATELY  
REARRESTED.

2. ACCORDING TO THE CIO, HIS OFFICE WILL ESCORT LAYTON  
FROM COURT TO THE AIRPORT IN A GUYANESE POLICE VEHICLE  
AND INSURE THAT LAYTON BOARDS THE AIRCRAFT. THE DPP EM-  
PHASIZED HIS CONCERN THAT IT NOT APPEAR THAT THE FBI WAS  
ARRESTING LAYTON IN GUYANA, AND THAT LAYTON'S AMERICAN  
ATTORNEY, CURRENTLY IN GUYANA, BE FULLY AWARE OF THE  
PLAN TO EXPLOR LAYTON. THE DPP WILL REQUEST THAT THE  
AMERICAN ATTORNEY ACCOMPANY LAYTON TO THE AIRPORT.

3. FOR SECSTAT (PPT/C): AS PER PARA 4 REFTTEL EMBASSY  
REQUESTED PERMISSION TO ISSUE CARD OF IDENTITY TO BE KEPT  
IN FBI CUSTODY.

4. FBI AGENTS IN GUYANA MAKE THE FOLLOWING REQUEST:

THAT FBI HQ COORDINATE WITH BWMRA ON ARRIVAL AT JFK  
IMMIGRATION-CUSTOMS AND THE FBI, SAN FRANCISCO, AGENTS  
MEET FLIGHT AT SFIA IN ORDER THAT LAYTON BE PRINTED  
AND PHOTOGRAPHER PREFERABLY THE SAME EVENING.

IF USM DO TRAVEL IT IS REQUESTED THAT THEY COORDINATE RETURN  
TO SAN FRANCISCO ON ABOVE PA AND US FLIGHTS

6. FBI HQ OR USM SHOULD INSURE THAT PAN AM AND UNITED  
AIRLINES ARE APPROPRIATELY ADVISED.
