LAYTON HAS BEEN DETAINED IN GUYANA BY RESTRAINING CRDER RESULTING FROM A CIVIL ACTION BY HIS DEFENSE ATTORNEY ALLEDGING AN INDEBTEDNESS OF \$37,000. HIGH COURT IN GUYANA HAS UPHELD INDEBTEDNESS BUT ON NOVEMBER 6, 1980, DISMISSED RESTRAINING CRDER AGAINST LAYTON.
