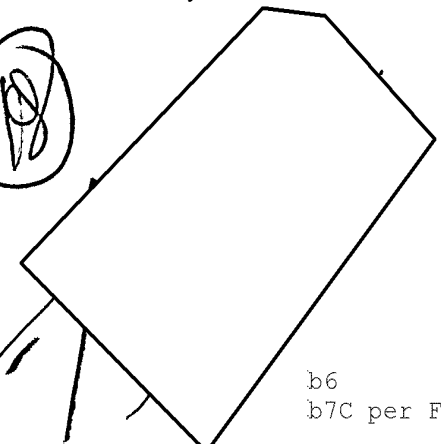

IN ADVANCE OF DATE OF APPEARANCE TO MAKE
ARRANGEMENTS. DEPT HAS ATTEMPTED TO TELEPHONE
DEFENSE COUNSEL TO OFFER ASSISTANCE BUT COUNSEL
HAVE NEGLECTED TO RETURN CALLS.
