AMEMB, GEORGETOWN,, INCLUDE COPY OF RESPONSES TO THESE  
MATTERS TO FBI, SAN JUAN TO FACILITATE EXPEDITIOUS TRANSMITTAL.  
THE FOLLOWING TEXT INCLUDES SEVERAL REQUESTS FOR  
CONTACTS WITH GOG IN BEHALF OF U.S. ATTORNEY AND FBI.  
SAN JUAN AGENTS ASSIGNED LIAISON WITH GUYANA ARE WILLING  
TO HANDLE THESE REQUESTS DIRECTLY WITH GOG SHOULD YOU PREFER.  
HOWEVER, IF EMBASSY FEELS IT WOULD PREFER TO OBTAIN INFORMATION  
THIS IS SATISFACTORY. ATTEMPTS AT REACHING EMBASSY BY  
LAND LINE PAST SEVERL DAYS MET WITH NO SUCCESS. MESSAGE

AS A RESULT OF CONFERENCE WITH SAN FRANCISCO U.S.  
ATTORNEY'S OFFICE PROSECUTION TEAM ON 19 MAY 81. U.S.  
ATTORNEY HAS THE FOLLOWING MATTERS OF CLARIFICATION AND  
REQUEST FROM GOVERNMENT OF GUYANA (GOG).

QM CONCERNING REFERENCED TELETYPE RE SUPPRESSION  
HEARINGS SCHEDULED FOR SAN FRANCISCO 7 JUL 81. HAS THE  
DIRECTOR OF PUBLIC PROSECUTION (DPP) IN GUYANA RESPONDED  
AS TO HIS OPINION CONCERNING NECESSARY GUYANESE WITNESSES  
TO SUCCESSFULLY REFUTE LAYTON ALLEGATION. AT PRESENT, U.S.  
ATTORNEY HAS REQUESTED THAT [REDACTED] INSPECTOR [REDACTED]  
DETECTIVE SUPERINTENDENT [REDACTED] AND SUPER NUMERARY  
[REDACTED] TO APPEAR.

WM AFTER THOROUGH CONSIDERATION CONCERNING TRIAL  
STRATEGY AND MAXIMUM JURY IMPACT U.S. ATTORNEY'S OFFICE  
WOULD PREFER THAT THE GUYANESE WITNESSES TESTIFY TOWARDS  
THE END OF THE TRIAL. U.S. ATTORNEY REALIZES THIS MAY PUT A

FOR INFORMATION OF AMERICAN EMBASSY, POSSIBILITY ALSO  
EXISTS THAT DEFENSE MAY ATTEMPT TO DELAY TRIAL THROUGH LEGAL  
APPEALS AND CHANGE OF VENUE. NO MOTIONS HAVE BEEN FILED TO  
DATE AND U.S. ATTORNEY CAN ONLY ASSUME TRIAL WILL PROCEED  
AS SCHEDULED BUT EMBASSY AND GOG SHOULD BE AWARE OF  
POSSIBILITY. PRE-TRIAL SUPPRESSION HEARING WOULD NOT BE  
AFFECTED BY SUCH MATTERS.

SAN JUAN IS REQUESTED TO COORDINATE WITH AMERICAN  
EMBASSY, GEORGETOWN CONCERNING ABOVE REQUEST AND QUESTIONS.

BUREAU IS REQUESTED TO RELAY TO U.S. STATE DEPARTMENT;
