- he kept asking us all night what this state was like, what that one was like.
- we explained that as in a large city, there were a lot of problems, like raping, shooting theft, as well as poverty and drugs, even offered to children
- I asked him if he was planning to go to the states, he said no, he was just dreaming,
- his wife, said we must do something to live...
- they both said they didn't want to go to England, it was too stuffy in England and they had lived there before for several years, and it was a city of tourists
- Bollers said he would like to go there and practice law at Hastings University
- I told them that both Mark Lane and Charles Garry had enjoyed meeting him and Mark had also promised to send them a book
