TO CLARIFY FOR YOU THE POSITION OF THE UNITED STATES GOVERNMENT WITH RESPECT TO THESE LAWSUITS, YOU ARE ADVISED:

- A. THE UNITED STATES IS NOT A PARTY TO ANY OF THESE LAW SUITS.
  - B. I WISH TO MAKE IT CLEAR THAT THE UNITED STATES GOVERNMENT (REPRESENTED BY OUR DEPARTMENT OF JUSTICE) IS STAYING INFORMED OF THE ACTIONS TAKEN BY THE OFFICIAL COURT APPOINTED RECEIVER FOR THE PEOPLE'S TEMPLE OF THE DISCIPLES OF CHRIST, A CALIFORNIA CORPORATION MR. ROBERT FABIAN OF SAN FRANCISCO, CALIFORNIA. MR. FABIAN VISITED GEORGETOWN JANUARY 20 AND 21, 1980 BUT UNFORTUNATELY WAS UNABLE TO VISIT WITH YOU.
  - C. THE OBJECTIVE OF THE UNITED STATES GOVERNMENT AND OF THE RECEIVER OF THE PEOPLE'S TEMPLE A CALIFORNIA CORPORATION IS TO WIND UP THE AFFAIRS OF BOTH OF THE PEOPLE'S TEMPLE ENTITIES SO THAT THE UNFORTUNATE

THE GOVERNMENT OF GUYANA IS NOT A PARTY. THE UNITED  
STATES GOVERNMENT HAS NO OBJECTION TO THE GOVERNMENT  
OF GUYANA DEALING DIRECTLY WITH MR. FABIAN OR HIS  
ATTORNEY THE UNITED STATES GOVERNMENT HOPES THAT  
THE ISSUES ARE QUICKLY AND AMICABLY  
RESOLVED TO BRING TO AN END THE UNFORTUNATE STATE  
OF AFFAIRS. I ASSURE YOU, MR. ATTORNEY GENERAL  
THAT YOU WILL RECEIVE THE FULL COOPERATION OF MY  
GOOD OFFICE IN OUR EFFORT TO BRING ABOUT AN  
AMICABLE SOLUTION OF THE PROBLEM.

2. DEPARTMENTS OF STATE AND JUSTICE ALSO REQUEST THE  
EMBASSY TO COOPERATE WITH AND PROVIDE ASSISTANCE AS  
APPROPRIATE TO THE LUCKFOO FIRM IN ITS ATTEMPTS TO  
DEFEND THE LITIGATION INITIATED IN GUYANA AND IN  
LIQUIDATING ANY REMAINING PT ASSETS WHICH COME INTO  
THE POSSESSION OF SAID LAW FIRM OR ITS AGENTS. VANCE
