2. "DEAR AMBASAADOR,

I DO REGRET THAT PRESSUPE OF WORK MADE ME POSTPONE
FOR SO LONG THIS REPLY TO YOUR THOUGHTFUL LETTER OF FEBRUARY
5, 1980 CONCERNING THE LAW SUITS INVOLVING THE PEOPLE'S TEMPLE
OF THE DISCIPLES OF CHRIST CHURCH IN GUYANA. YOUR CLARIFICATION
OF THE POSITION OF THE UNITED STATES GOVERNMENT WITH RESPECT TO
THOSE LAW SUITS WAS NOTED WITH UNDERSTANDING

THE LAW SUITS ARE FRAUGHT WITH LEGAL COMPLEXITIES OF
MANY KINDS BUT YOUR ARE NO DOUBT AWARE THAT NEGOTIATIONS FOR A
POSSIBLE STEELEMENT ARE IN TRAIN AND INDUCE SOME
OPTIMISM THAT THE END OF LITIGATION MAY BE IN SIGHT.
YOUR KIND OFFER OF THE USE OF YOUR GOOD OFFICES IN
BRINGING ABOUT AN AMICABLE SOLUTION IS APPRECIATED AND
WILL BE BORNE IN MIND SHOULD THE NEED FOR YOUR ASSIS-
