FORWARDING TO THE GUYANESE AUTHORITIES FOR THE  
TRANSPORTATION AND LOCAL LODGING OF THE  
AMERICAN WITNESSES. IT IS UNLIKELY THAT THE  
GOG WOULD CONCUR IN LODGING MR. GOSNEY AT THE  
PEGASUS, GEORGETOWN'S MOST EXPENSIVE HOTEL, AT  
GOG EXPENSE. WHILE RESERVATIONS HAVE BEEN MADE  
AT THE PEGASUS AS REQUESTED, THE EMBASSY ANTICIPATES  
THAT THE EVENTUAL REIMBURSEMENT FROM THE GOG WILL  
BE SOMEWHAT LESS THAN ACTUAL COSTS.
