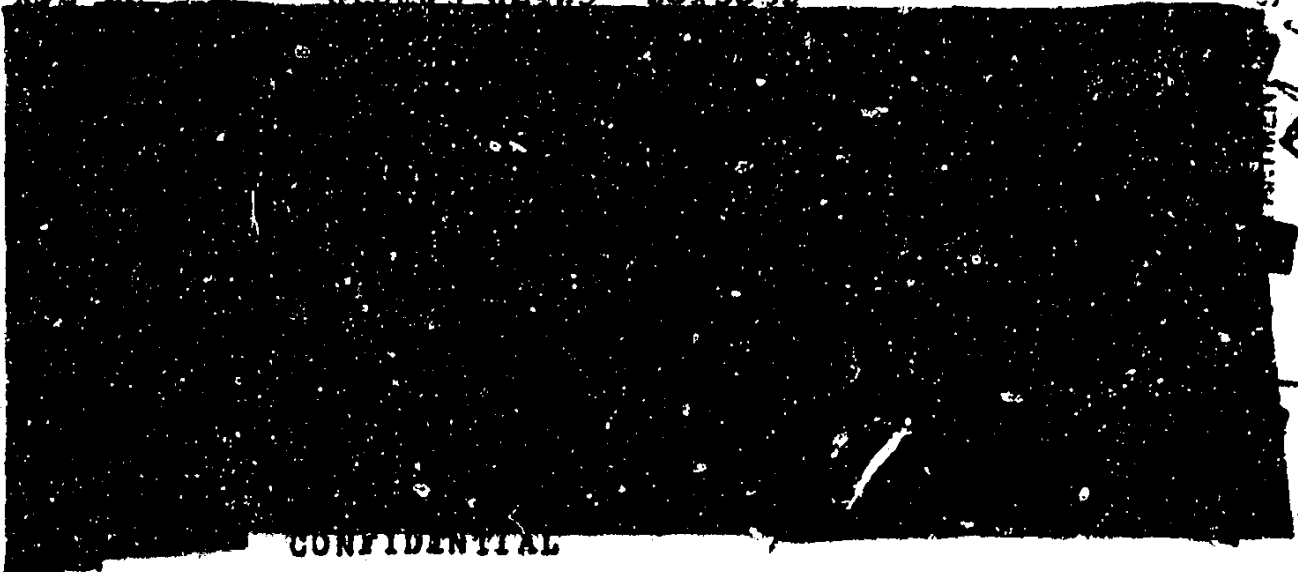

(U) THE REFERENCED TELEGRAM REPORTED THAT AMERICAN
CITIZEN LAWRENCE LAYTON WAS ACQUITTED ON MAY 22 IN
GEORGETOWN OF THE ATTEMPTED MURDERS OF VERNON JOSNEY AND
RONICA BAGBY AT THE PORT KAITUMA AIRSTRIP ON NOVEMBER
18, 1978. LAYTON, A MEMBER OF THE PEOPLES TEMPLE GROUP
FROM JONESTOWN, REMAINS CHARGED WITH THE MURDER OF
CONGRESSMAN LEO RYAN AND FOUR OTHERS ON THE SAME DATE.
THE GOVERNMENT OF GUYANA (GOG) MUST NOW DECIDE WHETHER
TO PROCEED WITH THE REMAINING CHARGES AGAINST LAYTON
OR TO DISMISS THEM LEAVING LAYTON A FREE MAN.
ACCORDING TO THE MEDIA, THE GOG'S DECISION IS EXPECTED
PROMPTLY.

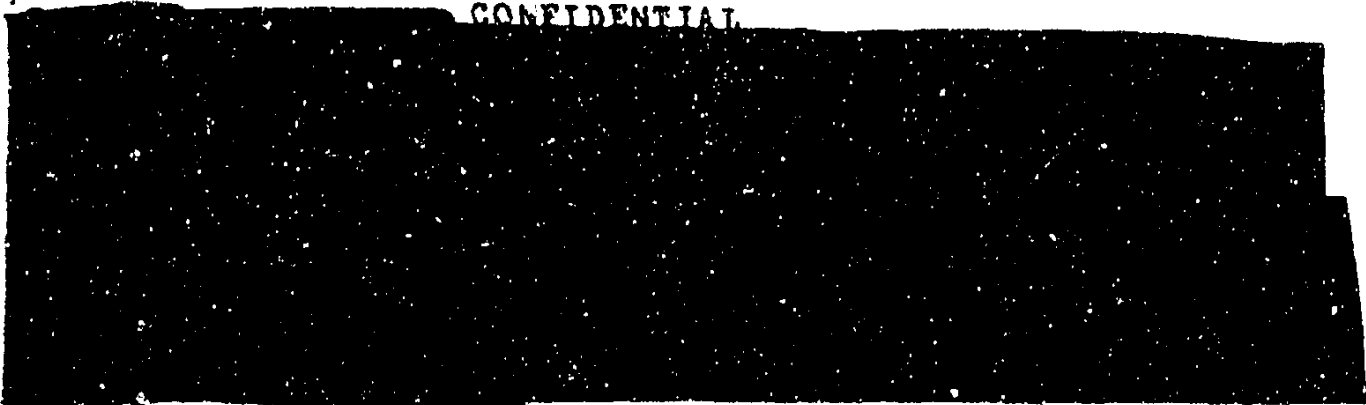
