Besides the addition of another sincere, committed member, I was overjoyed to have his help because in my rapidly growing church I needed a concerned, dedicated lawyer badley. I also needed an activist associ to minister badly and Tim Stoen rapidly began to fill both roles. I trusted him fully and entrusted him with more responsibility than any other single member of the organisation. He was my chief legal adviser and
