I am enclosing T.1.1 which is a list of materials requested from stateside, simply as a reference, and T.1.2 which is a list of recommended investigation areas. T.1.2 is significant in that articles are a good source of background material (we have requested that SF copy and send you our collection) and that reports of fires, bombings, telephone harassment were made to local law enforcement over the years.

The history of Peoples Temple goes back to the early days of the civil rights movement in the 1950s. A summary of Jim's working history is as follows: began past a church as an integration vehicle in early 1950s - United Cuba in 1957? and 1959. General secretary to the Commission on Human Rights, Indianapolis, Indiana about 1958-1961, while maintaining Church work in constant harassment during this 6-7 year period. 1962-1964 Escola da Favela, Bella Horizonte, Brazil. 1964 returned to Indianapolis.
