5. Premium Rates
The provisional rates obtained are as follows:

SINGLE MEMBER : \$ 1.80 per month
FAMILY RATE : 4.65 per month

There are discounts of 5% for semi annually and 10% for annual payments. We believe that we can obtain for you experience refund agreements of up to 50% of all profits made by the insurer in the first and subsequent years. We can also arrange to have the policy age limits extended to age 75 for normal benefits and to age 85 for slightly reduced benefits.

In due course, when you can let us have accurate census material we will go to the market for more accurate and competitive rates. In the mean while I look forward to your instructions.
