I still refused to say anything then one of the detectives brought in the Cathy Hunter. - saying he has been watching her & I all morning and wanted to know why I was looking all these phone calls. I refused to answer. Finally he said that the number 65787 has called to find out about Cathy's flight. I said "I don't know anything about it." He asked me my name, where I was originally from, where I'm staying. I said at Santa

Street and asked for the lot. I told  
 him I can't remember. But he knows  
 its in ~~Campville~~ Campville. Asked  
 where my parents are. I said "they  
 are in the state." asked when I  
 came to Durango & why? I asked them  
 #2 detectives I came in Sept. I came  
 because I heard its a nice place.  
 They as I was then asked who I'm  
 staying with. I said "I don't have  
 to answer nothing" one of the nasty  
 detectives said "if you keep it up  
 you won't be here much longer."  
 I thought about them sucking me  
 back to the state. which I don't  
 want let them do it. that might  
 cause a white night. trying  
 to prevent that I decided to  
 answer some of their questions.  
 I told them I was staying with  
 Terry Carter & Tim Carter. They  
 asked about our occupation I  
 said that Terry is a housewife.  
 Tim & I are not working now - they  
 asked how he survived I said  
 my parents started as ~~merchants~~ <sup>merchants</sup> they  
~~started from before~~ <sup>when they started</sup> ~~merchants~~ <sup>merchants</sup> couple  
 of months. When they asked  
 me about what I was doing  
 at the Passes I said refused to  
 answer when they took me to the  
 police station & began writing

my statement on a piece of paper.  
Officer Naught took the statement.  
He began with my name & questions  
such as, my name, where I was born  
where are my parents, what do my  
parents do, where I live in the  
State, My responds were my parents  
names are Gordon Lee & Fung Huey  
Lee. My dad is a seaman who  
is now on a leave of absence  
and my mother is a seamstress.  
I live at 644 Jackson St. Apt. # 7.  
Also asked what was my occupation  
back in the States. I told him I  
am left during my 3<sup>rd</sup> year in college  
and I had to just take job  
at the Sun Trade Center and  
take care of patients. Also he  
asked for my birth date & age. I  
said "I was born in Dec. 5, 1956."  
which he has already asked my  
at hotel but was by mistake he  
wrote down Dec. 15 1956. After  
all this he asked where is Terry's  
husband I told him he is in  
the northwest. He also asked again  
what he does there I said "  
he is in agriculture. Then asked  
if Terry is also from northwest and  
originally from the U.S. I said "yes".  
Also asked if he's married & have any  
children. I told him one son and

the child was in the southwest.  
He asked if you Terry's husband's  
name. I told him it is Jim  
Jones - asked for his nationality -  
respirated today. Then he asked he  
brought up Cathy Hunter how she  
is related to us. I told him  
she is not related to us, asked if  
I know her - I said "no" I have  
never met her before all I know  
is that she is a young girl  
write bad things about Peoples Temple  
asked if Tim Pao spoken at the school  
I told he no. Then he asked if  
she some member of Peoples Temple  
I said "no". ~~Continuing~~ asked He then  
began asking about Peoples Temple.  
~~about the life.~~ I said from experience  
and I told him I told him  
we are located in the southwest  
for Port. Kaituma we have started  
this agriculture project 4 years  
ago. We have a free medical clinic  
where that goes to the public.  
Then he said if I get sick can I  
come. I said "yes". Also I ~~to~~  
mentioned, we adopt needy children  
from here have adopted Japanese  
American etc. He asked if the  
headquarters is in S. G. I said "yes"  
and asked who's the leader I  
said Jim Jones. - asked where his

At 4:30 I was approached by 3 detectives and the hotel manager at an exit. The hotel manager said "you're not a guest are you?" I said "no" then he said "Where are you going?" I said "no where" The three detectives came and asked me again where was I going + am I looking for Cathy Hunter? I said "Cathy Hunter - Who's she?" They took me to the pool area + asked me my name + where I'm originally from I said I was from the States in CA. They asked me where my parents are I said they are in the states. Then asked me where I'm staying I said at Dennis then one of them ~~he~~ added in Campbell. Asked for the lot I told them I ~~can't~~ couldn't remember. Then asked who I'm staying with. I said some friends. Also asked if I'm attending school in Guyana. I responded no. Again asked for Tim's name which I finally gave and asked if I'm married to him. My answer was no.

I said he is in the northwest. Also asked for Jim Jones' nationality. I said "I don't know". The last question also on the Peoples Temple was the population I said over a thousand. He asked what I do in the interior. I told him I'm a school teacher - teach 8-9 year of age pupils - teach them read & write. Going back he asked me how long have I been in Guyana and do I have a passport and did my passport <sup>state that</sup> I would stay here permanently. I told him in the passport it stated 2 weeks visit. After begin here I decided to make

the lastly, he said he will check it  
out tomorrow & give me <sup>the house</sup> a call and I  
signed my name.

this very time I went to immigration  
to have them sign me a passport  
for stay which they did. ~~the~~  
Just before the end he again  
asked why I was going up stairs  
I told him I was just curious  
when I saw the lad going up  
since I've never been to the  
Plyms before. I said to him  
I wouldn't have gone up if  
there was a sign saying  
restricted and I also said  
in the U.S. where there no sign  
it is open to the public.  
I also said if it was your first  
time you would have done it too.  
Just going back once more to the  
hotel. I was told that I've been  
there before. I denied that strongly.  
About making the phone calls, I  
told them I have the right to  
them was nothing wrong calling  
home but he one of the Detectives  
said the number 2-68787 is  
not my home. I yelled at him  
saying it is my home phone.  
I know I live there. But he kept  
on arguing it. When I arrived  
at the police station I was told that  
if my statement is the truth I will  
not be arrested because I didn't  
do anything serious saying that  
a restricted area open to hotel guests only.
