

- 13. FAGE 23: Reprint Dennis Banks' statement -- preferably the original document, not the Feoples Forum reprint, providing its easily readable.

Like a kind of "spy" -- definitely with an aura of mystery, intrigue.

- 24. Page 27: Good if we can take a picture of Conn's house and publish it, with caption of his house and the addresss Say that this is the scene of secret meetings to plan the campaign against Jim Jones. "Fast Bay Home"
- 25. Page 28: Between second and last peramgraph on this page, cut in a collage of the front page headlines on the "break in" that appeared in the Examiner and Chronicle. Use the banners of the papers to show it was on the front pages. Or caption the visual thus: Front-page coverage of the "break in"—
 There may be other articles in the file that have to do with the "strange break-in at New West"—— use those in the collage, but feature the Chron and Examiner ones. Don't reprint the articles here— just the headlines and a few words of text, perhaps.
- 26. Page 29: Picture of New West offices on 325 Pacific street. (maybe go out and get a picture of the place, preferabley place where break in was supposed to occur the buildingshowing the window that was entered, but not just the window.)

Show a man who is dressed like a journalist (maybe wearing the typical cap/visor of the journalist) who is painting a portrait of a man standing at a distance. The man looks very ordinary. 



Page 5 will be the Table of Contents page. Its heading should only be CONTENTS

Here is the Table of Contents, using the page numbers that are on the manuscript. Of course, they will change when you make the book up. Note that the Contents are Divided into major headings and sub-headings, along with appendices. You could conceivably have a separate table of contents for the appendices, listing each document, article, letter separately. You may decide to do this, though it is not absolutely necessary.

(note again: you may want to break down Appendix I and list every separate document. They are all referred to in the footnotes)

There should be a title page before the Appendix section which merely had one world on it: APPENDICES

In addition, there should be a title page before <u>each</u> separate appendix, stating the title of each appendix.

There can also be a title page for Book I and one for Book II. These title pages need only say BOOK I and the title of the BOOK (Title for BOOK I is Foundations; totle for BOOK II is Conspiracy!).



In Book-I, each seaparate section should begin on a new page. In Book II, begin each of the six manjor sections on new pages.

ADDITIONAL NOTES: Please cut in a lot of quotes into the text. The dummy book that you sent had a lot of nice ones: from Hazel Grossman, Justice Brandeis, Willie Brown, etc. They help focus attention. You can even take more excerpts from letters of support and cut them in. Some nice sections of Goodlett's editorial can be appropriately inserted in the text at right time. These should be done by boxing them off and using different type faces.

Another visual: There is a shot of Jim carrying a picket sign in Fresno, also other nice shots of the Fresno march that would be good to cut in in the section stating that we have participated

I have not detailed the letters and statements and articles of support for Appendix V. I think that we should use the letters to Burnham, the Golden and Goodlett statements, various letters to the editor of the Forum we have received (Snedecker, Hellman, others), plus some of the older quotes. You might just want to limit this to statements concerning the attacks on us (of recent date), and skip the older stuff. You possibly can use some of the nicer older quotes—— a bunch of them were printed in the August Forum on page 4—— and put them not in the appendix, but in the text (first book) as appropriate.

It's possible that you could print the text only on the right hand pages (as in your dummy book) and reserve the left-hadd side for the visuals, quotes, etc. The point is to get variety into the text, using visuals, quotes, etc. to break up the flow, i yet without destroying but enhancing the continuity of the narrative.

Also: on the title pages for Book I xMM and Book II, try to find a suitable quote to put on each. The quote should be broad and profound enough to provide an epigraph for the material of the entire book.
