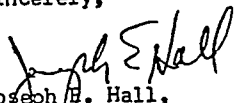

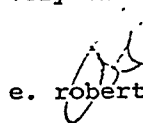
Dear Ms. Brown:

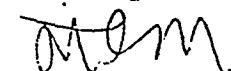
Dear Ms. Johnson:
