Dear Charles:

I am writing this letter in the hope of improving our communications and, hopefully, improving the relationship that exists between you and the Temple.

The key to the problem basically rests in the answer to the question "What is going on?" direct to the activities of the Temple Organization. The answer must be for Temple collecting and for the Temple. In our view the role of the Temple is to represent us in need, address solutions to problems, and act as the director of our efforts or tactics. This must be done with respect to our common, religious, and investigation.

Letting down of the spirit is we did not appreciate the following. The organization of our community is a personal time reminder that when we were in the Temple down, when our churches were burned, when a bomb was placed in the Temple, when we were shot at - you were not there. When you advise - demand - that we take certain actions are not such that you represent the Temple. Second, we do not appreciate your forcing a discussion of confidential material in front of a person who is not a member by a privilege, especially when that person has long been a part of the Temple.
